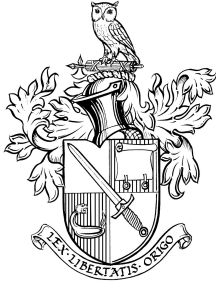

## **The conscience of the corporation? Ethics and regulation for the in-house lawyer**

The City of London Solicitors' Company will shortly be holding the next in its 'Food for Thought' series of discussions regarding matters of ethics. This time we will be facilitating a conversation by and for in-house lawyers.

The event, which will be held at Freshfields Bruckhaus Deringer's London office on 20 April, will explore the conceptual and practical issues faced by lawyers who practise in-house, whether there is a case for reform of the way this growing part of the profession is regulated, and what that might look like.

**Jenifer Swallow** is an award-winning GC, business innovator and coach. Jenifer has extensive experience leading in-house teams at innovative technology and media companies and was identified by the Legal 500 as one of the global profession's 100 most influential GCs during her time at TransferWise. Jenifer has also written and spoken about the ethical and regulatory challenges associated with in-house practice.

**Dr Karen Nokes** is a lecturer at UCL, where she uses insights from psychology and business and management to explore human behaviour within the legal system. Prior to joining academia, Karen was previously with the Law Society/Solicitors Regulation Authority where she held a number of senior posts over twenty years including Head of Casework Investigations, Head of Practice Standards and Director of Supervision.

**Marianne Butler** is a commercial barrister. Her practice in the area of professional regulation and discipline has led to her being recognised as Chambers & Partners' 'Professional Discipline Junior of the Year' 2022. Marianne's experience working for regulators, as well as law firms and other regulated persons, makes her an effective and sought after advocate as well as a perceptive commentator.

The panel session will be hosted by Jonathan Kembery. Jonathan is a partner with Freshfields and the firm's global GC. Jonathan has more than twenty years' experience leading in-house teams and served for more than a decade on Solicitors Regulation Authority and City of London Law Society committees looking at regulatory and ethical matters.
