He practised primarily in employment law and human rights, acted in most of the major industrial disputes over the past decades and is an approved counsel for the Equality and Human Rights Commission.
- **Iain Miller**, Partner of Kingsley Napley LLP, and General Editor of Cordery. Iain specialises in legal ethics, investigations, and public law matters and has acted in many of the leading cases relating to the regulation of lawyers in England and Wales.
